Minutes of the Chicopee Board of Assessors April 8, 2020 meeting. Meeting called to order at 10:30 a.m.

Present: Victor Michael Anop and Brian Suchy

1. Motion by Assessor Anop to accept the minutes of the April 1, 2020 meeting. Seconded by Assessor Suchy. Voted unanimously.
2. Motion by Assessor Suchy to act upon and sign all qualified exemption applications before the Board.
3. DISCUSSION: a.) One of our employees was 14 day quarantined (without symptoms) because a family member was infected with COVID 19. The worker can not return until at least April 22nd. Our office was double disinfected. All essential office personnel in our office have their temperatures taken by a nurse at the entrance of city hall, and would be turned away if they are above normal or show or tell of any symptoms. The Mayor and HR urged all employees who don't feel well not to come to work. b.) Assessor Suchy noted that he is finishing updating personal property accounts and utilities valuations. Suchy has been in charge of scheduling the rotation of our workers, placing the data on calendar spread sheets, and seeing the Mayor's Office is informed. c.) Mayor Vieau has taken several actions to enforce "social distancing" at open businesses, providing aid opportunities for local business, and most recently providing city block grant funds for Lorraine's Soup Kitchen, and other social help agencies. d.) Assessor Anop has been consulting with Collector Iwanicki and the Mayor's office on Chapter 53 of the Acts of 2020 which extends property tax payment deadlines to June 30, 2020, without interest or penalties. Our office is working on notifying Chicopee residents about the changes due to the pandemic's effect. e.) Assessor Suchy said there was a complaint and warning issued by Mayoral aide Beaulieu regarding an employee smoking openly on city grounds. The employee was warned of not violating the long-standing policy. There were no votes taken on these matters.
4. Motion by Assessor Anop that the next Board meeting be held Wednesday, April 15, 2020 at 10:30 a.m. Seconded by Assessor Suchy. Voted unanimously.
5. There being no further business before the Board, motion by Assessor Suchy to adjourn. Seconded by Assessor Anop. Voted unanimously. Meeting adjourned at 11:20 a.m.


