
April 22, 2020

Minutes of the Chicopee Board of Assessors April 22, 2020 meeting. Meeting called to order at 10:30 a.m.

Present: Victor Michael Anop and Brian Suchy

1. Motion by Assessor Anop to accept the minutes of the April 22, 2020 meeting Seconded by Assessor Suchy. Voted unanimously.
2. DISCUSSION: a.) The Assessors office continues working on all business days from 9 a.m. to 4 p.m. as an "essential office" with Assessors Anop and Suchy working each day, and 2 of the 4 staffers rotating work weeks. b.) Senior Clerk Delgado was questioned about inputting deeds into the Vision valuation system, and she said that it appears that January & February, 2020 deeds have not been inputted yet, and March wasn't downloaded from the Registry of Deeds. Assessor Anop and Suchy said doing this project is a priority item. c.) Delgado added that Mass.Registry of Motor Vehicles has delivered data for a new motor vehicle commitment of 3,262. The Collector and Delgado have not set a day with Art Jones for a billing to be sent, and are watching the effect of COVID 19 developments. Mayor Vieau has already adopted the state law allowing for bills issued after March 10<sup>th</sup> to be paid by June 30<sup>th</sup> without interest or penalties. d.) Assessors continue working on budgeting for FY 2021, and valuation of all property in Chicopee for FY 2021. There were no votes taken on these matters.
3. Motion by Assessor Suchy that the next Board meeting be held Wednesday, April 29, 2020 at 10:30 a.m. Seconded by Assessor Anop. Voted unanimously.
4. There being no further business before the Board, motion by Assessor Anop to adjourn. Seconded by Assessor Suchy. Voted unanimously. Meeting adjourned at 11:21 a.m.
