- MO-13 Whereas, The City Council of the City of Chicopee strongly supports increased economic development to provide additional jobs for residents of Chicopee, Holyoke, and Westfield and expanded commercial and industrial activity within those cities in order to promote and develop a healthy economy and a stronger tax base; and

Whereas, the General Court has enacted M.G.L. Ch. 23A Section 3A-3H, the Massachusetts Economic Development Incentive Program (EDIP), designed to stimulate job creation, attract new business, encourage growth of existing businesses, and to increase overall economic development readiness; and

Whereas, The City of Chicopee has entered into an Inter municipal Agreement with the Cities of Holyoke and Westfield and the three cities have been designated as the Holyoke Regional Economic Target Area (ETA), by the Economic Assistance Coordinating Council (EACC); and

Whereas, The City Council of the City of Chicopee desires job creation opportunities, improvements to distressed commercial properties, and increased economic opportunities within Chicopee; and

Whereas, the City Council of the City of Chicopee has supported the productive reuse of property at 301 Griffith Road; and

Whereas, UFP Site Built, LLC and Griffith Road Property Owner, LLC is investing \$1,400,000 in property improvements; and

Whereas, UFP Site Built, LLC and Griffith Road Property Owner, LLC has committed to create a minimum of 60 permanent full time jobs with preference in hiring residents of the ETA and the City of Chicopee; and

Now, Therefore, be it ordered, and the City Council approves the Certified Project application of UFP Site Built, LLC and Griffith Road Property Owner, LLC and forwards said application for certification to the Massachusetts EACC for its approval and endorsement;

Be it further ordered, the City Council of the City of Chicopee with approval of the Mayor hereby makes a binding commitment to enter into an Tax Increment Financing (TIF) agreement with UFP Site Built, LLC and Griffith Road Property Owner, LLC;

And be it further ordered, that pursuant to M.G.L. Ch. 23A Section 3E, the TIF agreement with UFP Site Built, LLC and Griffith Road Property Owner, LLC shall comply with all laws and regulations regulating such agreements and shall include only exemptions contained in this Order. Said Agreement will provide an exemption on property taxes based on the growth portion in the assessed value of the project. The base valuation shall be determined by the City Assessors as of January 1 of the year after the issuance of a Certificate of Occupancy. Subject to the terms and conditions of the Agreement, Tax Increment Financing Agreement exemption to be applied to the Project Premises is as follows, and such below stated percentage shall be utilized in calculating the real property tax due with respect to the Premises for such respective fiscal year:

First Fiscal Year - 70% of the increased assessed value 50% of the increase assessed value Third Fiscal Year - 20% of the increase assessed value 5% of the increase assessed value Fifth Fiscal Year - 5% of the increase assessed value

--Motion made by Councilor Brooks to receive and pass. Councilor Brooks stated will help the property owner who is investing 1.4 million dollars to get jobs. Councilor Balakier stated vacant building will have 60 full time jobs. Economic growth for the city. Councilor McAuliffe stated good to vote yes and see the board vote yes on economic growth. Motion passed through all stages by a unanimous roll call vote.

 - 5. A letter from the State allowing the use of Esser monies given the School Department of \$8.3 Million for the purchase of Administrative Offices is allowed under Esser Fund use requirements.
