


The items to be discussed include the agenda items listed below and general City of Chicopee updates.

MO-1 Ordered that the City Council accept the attached grant amendment from the Massachusetts Department of Environmental Protection in the amount of Six million nine hundred thirty-six thousand thirty-nine and 00/100 dollars (\$6,936,039.00) to the City of Chicopee. Said grant will be used to reduce the effluent nitrogen as required by the City's federal and state issued NPDES permit and it is accepted in accordance with M.G.L. Chapter 44 Section 53A.
