




1. BE IT ORDERED THAT the DPW install a no truck sign for Ludlow Road and be referred to the Ordinance Committee for a public hearing. (Pniak-Costello/Laflamme)
2. BE IT ORDERED THAT the Law Dept., the Building Dept., and Board of Health provide input to the Ordinance Committee to establish a new ordinance involving vehicle size on private property. Refer to the Ordinance Committee for public hearing. (Pniak-Costello)
3. BE IT ORDERED THAT the final budget for the city be voted in 2 weeks before the end of fiscal year be sent to the Ordinance Committee. (Dobosz, Courchesne, López, Pniak-Costello)
4. BE IT ORDERED THAT no doxing be referred to the Ordinance Committee for a public hearing. (Pniak-Costello)
5. BE IT ORDAINED by the City Council that the Code of the City of Chicopee for the Year 1991, as amended, be and is hereby further amended as follows:

Delete Chapter 200-5 Dumpsters

Dropoff, pickup, emptying and removal of trash container dumpsters within 1,000 feet of any residential zone shall be prohibited between the hours of 10:00 pm and 7:00 am.

And insert in place thereof

Dropoff, pickup, emptying and removal of trash container dumpsters in a residential zone shall be prohibited between the hours of 10:00 pm. and 7:00 am. (Krampits)

6. **CAREW STREET** - East (Odd) side – From East Main Street to a point 980 feet southerly thereof - **NO PARKING, STOPPING OR STANDING** (Krampits)
7. **WESTOVER ROAD** - Both sides – From westerly entrance of the Western Massachusetts Post 9-11 & Service Dog Memorial Park parking lot to a point 4,650 feet easterly thereof at the easterly end of Westover Road - **TRUCK PARKING PROHIBITED** (Laflamme)
8. **CAREW STREET** – West (even) side – From East Main Street to a point 630 feet southerly thereof – **NO TRUCK IDLING** (Krampits)
9. **EAST MAIN STREET** - Both Sides – From Carew Street to the American Legion Memorial Bridge - **NO PARKING, STOPPING OR STANDING** (Krampits)
